There will be no Markman hearing in this Investigation in advance of the main hearing. However, the parties should note that the procedural schedule reserves part of January 24, 2011 for technology tutorials prior to the hearing in this Investigation. (See Order No. 5.) The Administrative Law Judge finds that brief technology tutorials will be useful in setting the stage for the hearing. Complainants and Respondent will be permitted 30 minutes per side to present the technology at issue in this Investigation. Legal argument during said presentations will not be permitted.

Following the technology tutorials, the Administrative Law Judge will permit the parties to present Markman <u>tutorials</u> providing an overview of claim construction issues with respect to the patents at issue in this Investigation. Complainants, Respondent, and Staff will be permitted 30 minutes per side to summarize their legal arguments with respect to claim construction. Rebuttal arguments will not be permitted.

Said tutorials will occur in Hearing Room A starting at 9:00 a.m. on January 24, 2011. The

pre-hearing conference and evidentiary hearing will commence immediately after the tutorials.
