By publication of a notice in the *Federal Register* on July 16, 2015, pursuant to subsection (b) of section 337 of the Tariff Act of 1930, as amended, the Commission instituted this investigation to determine:

[W]hether there is a violation of subsection (a)(1)(B) of section 337 in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain toner supply containers and components thereof by reason of infringement of one or more of claims 1, 7-9, 11, 16-18, 29, and 38 of the '094 patent [U.S. Patent No. 8,909,094] and claims 1, 7-9, and 16 of the '820 patent [U.S. Patent No. 9,046,820], and whether an industry in the United States exists as required by subsection (a)(2) of section 337.

80 Fed. Reg. 42119 (July 16, 2015).

The complainants are Canon Inc. of Tokyo, Japan; Canon U.S.A., Inc. of Melville, New York; and Canon Virginia, Inc. of Newport News, Virginia. The named respondents are General Plastic Industrial Co., Ltd. of Taichung County, Taiwan and Color Imaging, Inc. of Norcross, Georgia. The Office of Unfair Import Investigations was not named as a party to this investigation. *Id.*

Based upon the complaint and the other submissions of the parties to date, it is determined that the target date for completion of this investigation is September 16, 2015, which is two months after institution of the investigation. *See* 19 C.F.R. § 210.51(a).
