DENYING VALEO'S MOTION FOR SUMMARY
DETERMINATION ON THE ECONOMIC PRONG OF THE
DOMESTIC INDUSTRY REQUIREMENT

(June 25, 2015)

On May 13, 2015, Complainants Valeo North America, Inc. and Delmex de Juarez S. de R.L. de C.V. (collectively, "Valeo") filed a motion for summary determination on the economic prong of the domestic industry requirement. (Motion Docket No. 928-019.) On May 26, 2015, Respondents Trico Products Corporation and Trico Componentes SA de CV (collectively, "Trico") filed an opposition to Valeo's motion.

Having thoroughly reviewed and considered the pleadings and exhibits attached thereto, and drawing all justifiable inferences in Trico's favor, I find that summary determination is inappropriate because genuine issues of material fact remain. Accordingly, good cause does not exist to grant Valeo's motion in lieu of a trial of all issues on the merits and Valeo's motion is hereby DENIED.
