(June 30, 2015)

On May 13, 2015, Respondents Trico Products Corporation and Trico Componentes SA de CV (collectively, "Trico") filed a motion for summary determination of non-infringement. (Motion Docket No. 928-021.) On May 26, 2015, Complainants Valeo North America, Inc. and Delmex de Juarez S. de R.L. de C.V. (collectively, "Valeo") filed an opposition to Trico's motion.

Having thoroughly reviewed and considered the pleadings and exhibits attached thereto, and drawing all justifiable inferences in Valeo's favor, I find that summary determination is inappropriate because genuine issues of material fact remain. Accordingly, good cause does not exist to grant Trico's motion in lieu of a trial of all issues on the merits and Trico's motion is hereby DENIED.
