On October 31, 2018, and pursuant to Order No. 2, the parties in this investigation submitted a joint proposal requesting I set a target date of March 4, 2020. *See* EDIS Doc. ID. 660513 ("Joint Statement Proposing Target Date") (Oct. 31, 2018). The parties' proposal amounts to a request for a 17-month target date.

I. TARGET DATE

Considering the parties' proposal, as well as my responsibilities in other investigations, I have determined to set a 16-month target date of February 12, 2020, for this investigation.

Accordingly, any final initial determination shall be due no later than October 12, 2019. See 19

C.F.R. § 210.42(a)(1)(i).

II. PRELIMINARY CONFERENCE

Consistent with Ground Rule 3, a preliminary conference will be on November 19, 2018, at the U.S. International Trade Commission in Washington, DC. In preparing a proposed

procedural schedule, as required by the same rule, the parties shall take the following dates into account:

- A Markman hearing will be held on February 6, 2019 at 9:00am ET.
- The final pre-hearing conference will be held on June 21, 2019 at 9:00am ET.
- The evidentiary hearing will begin on June 24, 2019 and will conclude no later than June 28, 2019.
