In view of Order No. 43 granting Complainants' motion to terminate the Remand Investigation with respect to Trico's products with the 618 and 596 connectors, the Commission's Remand Order dated December 21, 2015, directing me to: (1) make findings regarding whether Trico products with 618 and 596 connectors infringe the Asserted Patents; and (2) issue an ID within 30 days of the Remand Order extending the target date; is MOOT.
